The City of Rio Vista is accepting applications for the position of **Maintenance Worker I/II**. The position will be filled at either the Maintenance Worker I or Maintenance Worker II level depending on the qualifying candidate's experience. Under general supervision, performs a wide variety of skilled, semi-skilled and routine duties assigned to classes within the series including constructing, repairing and maintaining City streets, parks, landscaping, airport, pool and water, sewer and building facilities; learns policies, procedures and work methods associated with assigned duties.

Maintenance Worker I

This is the entry level class within the Maintenance Worker series. Positions in this classification are responsible for a wide variety of less difficult and complex tasks and receive on-the-job training in the performance of more complex duties.

Maintenance Worker II

This is the journey level class within the Maintenance Worker series. Positions in this classification are responsible for a wide variety of maintenance and construction tasks. This classification is distinguished from the next lower classification of Maintenance Worker I by the performance of more complex, semi-skilled and skilled tasks. Receives general supervision from the Public Works Superintendent and other Public Works classifications. Incumbents may assist in the training of other Public Works related positions.

Qualifications: One year of increasingly responsible experience in the maintenance, repair and alteration of buildings, grounds and facilities, or related work, at a semi-skilled level, or equivalent. Experience, training or certification in any of the building trades, landscaping, and water treatment operations is desirable. **Water Treatment Operator I (T1) and/or Water Distribution System Certificate I (D1) preferred.** Possession of a valid Class C California driver's license at the time of appointment, to be maintained as a condition of continued employment. Position requires sitting, standing, walking on level and slippery surfaces, reaching, twisting, turning, kneeling, bending, stooping, squatting, grasping and making repetitive hand movements. Serves on Public Works "on-call" rotation, as scheduled.

Compensation includes an excellent benefits package: CalPERS Retirement, 90% employer-paid family medical coverage and 100% employer-paid dental, vision, and life insurance. Paid time off that includes 12 days of vacation, 15 holidays, and 96 hours sick leave.
