WATER UTILITY WORKER TECHNICIAN

Under general supervision, learns to perform and performs a variety of skilled or semi-skilled maintenance work on the City's water treatment system; responds to a wide range of customer service requests; reads water meters; tests water samples on a regular basis; operates a variety of water treatment facility duties, including hand and power tools, operation logs; adding and mixing of treatment chemicals; demonstrates a full understanding of all applicable policies, procedures and work methods associated with assigned duties; assists in the training of less experienced personnel; performs other related duties as required. The **Water Utility Worker Technician** is the journey level class as a Water Utility Worker in which incumbents are expected to independently perform the full scope of assigned water utility duties.

Qualifications: Any combination of education and experience that has provided the knowledge, skills and abilities necessary for a Water Utility Worker Technician. A typical way of obtaining the required qualifications would be equivalent to the completion of the twelfth grade supplemented by specialized training in water treatment facility operations. Experience commensurate with each grade level of certification as required by the State of California, which includes some courses in the area of assignment. Possess Water Treatment Operator II, possess Distribution System Certificate II, and within 12-24 months of hire, obtain Water Treatment Operator Certificate III, all issued by the State of California. Possession of a valid Class C California driver's license at the time of appointment, to be maintained as a condition of continued employment.
